IT IS HEREBY ORDERED THAT:

- 1. The Association shall have no quorum requirements for both (i) the election initiated on January 18, 2012 to choose initial directors of the Association, and, (ii) provided secret ballots are delivered to all record members pursuant to Civil Code Section 1363.03, any future secret ballots initiated by Members or Directors of the Association for a ONE Year period of five years from the date of this Order;
- 2. Mr. Roy Helsing, acting as Inspector of Elections, shall open, count and tabulate the Secret Ballots in Mr. Helsing's possession that were cast by Members of the Association as of February 27, 2012 at an open meeting of the Association, for which meeting Members shall have 10 days written notice. Mr. Helsing shall determine the three persons who received the most votes from these secret ballots, pursuant to the Bylaws; the Covenants, Conditions and Restrictions; and California law without consideration of whether a quorum was reached;
